



## 2 Installation

### Installation Environment:

Support outdoor use.

Avoid backlight, direct sunlight, and indirect sunlight For Better recognition, there should be light source in or near the installation environment.

The minimum bearing weight of the wall or other places should be 3 times heavier than the device weight



### Wall Mounting

Secure the mounting plate on the wall with 4 supplied screws (SC-KA4X25-SUS).




**2** Route the cables through the cable hole of the mounting plate, and connect to the corresponding external devices' cables.




Apply silicone sealant among the cable wiring area to keep the raindrop from entering.

Align the device with the mounting plate, and secure the device on the mounting plate with 1 supplied screw (SC-KM3X6-T10-SUS).



### 3.1 Wiring (Normal) When connecting door contact and exit button, the device and the RS-485 card reader should use the same common ground connection.
